WHY SHOULD YOU VOTE?

Voting is one of the most powerful ways to make your voice heard in our democracy, but in 2020, only 66.8% of the voting-age population in the United States reported voting.

Modern technology has improved access to information on candidates and made it easier to register to vote in many areas, and it is vital to be aware of how you can participate in the 2024 election cycle.

October 7 in-person or postmarked; October 15 online

Thirty days before an election; 20 days before if registering online.

ABSENTEE / MAIL-IN VOTING BALLOT DEADLINES:

Request must be received by

November 1

Four days before the election at 4:30 PM.

BALLOT SUBMISSION DEADLINE:

All absentee ballots, regardless of return method, must be received the day before the election by 4:30 PM. Mail Receipt by Election Day
