Dear Secretary Azar,

We write to urge you to return to the bargaining table and negotiate employment contracts in good faith with unions representing employees of the Department of Health and Human Services (HHS). HHS is required by law to negotiate in good faith and doing so is critical for its mission to protect the health and well-being of Americans.

HHS management failed to negotiate in good faith with union representatives when management walked out on negotiations after just one day of discussions last year. By failing to negotiate in good faith, HHS is in violation of federal law. The Federal Service Labor-Management Relations Statute requires that HHS, like other federal agencies, “shall meet and negotiate in good faith for the purposes of arriving at a collective bargaining agreement.”¹

This violation of labor laws is particularly troubling because HHS employees serve critical functions in protecting the safety of Americans. The tens of thousands of individuals that work at HHS all play an important role in helping the Department meet its mission “to enhance and protect the health and well-being of all Americans.”² Dedicated public servants shouldn’t have to divert their attention from helping HHS meet its mission to worry about the burden of anti-employee policies because management is failing to negotiate in good faith.

On September 30, 2019, an arbitrator found that HHS “committed an Unfair Labor Practice by bargaining in bad faith.”³ Following this decision, the head of one of the unions representing HHS employees wrote to you requesting that negotiations be resumed.⁴ We understand that you have not responded to this request, and we urge you to return to the negotiating table as soon as possible.



For the sake of the health and well-being of your employees and all Americans, we urge you to return to the negotiating table with unions representing HHS employees.


